



## Minor Permission Form

**To be completed by the parents/legal guardian of children who will attend a Coastwalk under the supervision of another relative or responsible adult over the age of 25.**

### **Coastwalk Policy for Attendance of Minors on a Coastwalk**

1. All minor children on a Coastwalk must be accompanied by their parent/legal guardian or another relative or responsible adult over the age of 25.
2. A minor child is any person under 18 years of age.
3. If a minor is not accompanied by their parent/legal guardian, the relative or responsible person accompanying the minor must be approved in writing by the parent/legal guardian.
4. The parent/legal guardian of the minor attending the Coastwalk must complete the Acknowledgement and Assumption of Risks & Release and Indemnification form on behalf of their child. The Minor Permission Form must also be completed if the minor is not attending the Coastwalk with a parent/legal guardian.

I understand that Coastwalk is an event for adults and minors under the care of responsible adults. Coastwalk does not act *in loco parentis*, in that it does not provide care as a substitute parent. Rather, the responsible adult attending Coastwalk with a minor is responsible for the minor's care and safety. I understand that Coastwalk is not a summer camp or similar experience, that is, it is not designed for unaccompanied minors.

I also agree to release Coastwalk from any liability incurred as the result of my child's participation and understand that I must sign the Acknowledgement & Assumption of Risks & Release & Indemnification form as well as this form in order for my child to attend Coastwalk.

Should my child need to return home, due to illness or other reasons as determined by Coastwalk, I agree to provide transportation or make other arrangements for my child's safe delivery home. In the event that I cannot be immediately contacted, I agree to assume financial responsibility for alternative arrangements that may have to be made by Coastwalk.

I have read and understand the Coastwalk policy regarding attendance of minors on a Coastwalk as well as the foregoing release and agree to it on behalf of said minor children.
