

Acknowledgement and Assumption of Risks & Release and Indemnification (Liability Form)



Coastwalk requires that each adult participant, or parent/legal guardian of minor children attending the Coastwalk with another relative or responsible person, read, sign and return this release form when registering for a Coastwalk.

You must sign one liability release for each walk for which you are registering. Please photocopy this form as needed, or download additional forms from our website: www.coastwalk.org.

I understand that by participating in Coastwalk, I, or my minor children, may be exposed to a variety of dangerous conditions, hazards, and risks, both foreseen and unforeseen. I understand that I (they) will be participating in an outing that may include the danger of damage to my property, injury to myself, or death ("damages"). I know that these damages can occur from natural conditions, acts of nature, or by the actions of animals, other Coastwalk participants, Coastwalk members, volunteers, or leaders, or third parties not associated with Coastwalk. I know that these damages can occur as a result of negligence or because of other reasons.

I understand that risks of such damages are inherent in an activity such as Coastwalk, and I appreciate that I may have to exercise extra care for my own safety, as well as for the safety of those around me in the face of such hazards.

I further understand that on Coastwalk there may not be rescue or medical facilities or expertise necessary to deal with the damages to which I may be exposed. I understand that these risks exist, and yet I still wish to participate in this outing and will pay the required fee for it.

In exchange for my acceptance as a participant in this Coastwalk outing, and for the services provided by Coastwalk in connection with it, I confirm that I have read the foregoing and voluntarily assume all risks of any damages that may occur in connection with the outing. I also agree to hold Coastwalk harmless for, and hereby waive, release and discharge all claims I might have for any damages against Coastwalk (which includes its officers, directors, employees, members, volunteers, leaders, and agents), even though those damages may result from the negligence of Coastwalk. I intend that this agreement shall bind my heirs, executors, administrators and assigns, and shall include any minors accompanying me on the outing.

I also understand that the leader or leaders in charge of Coastwalk each day have the authority to enforce safety rules. By signing this release I am also agreeing that I will abide by the Coastwalk rules applicable to this outing.

I certify that I have no medical condition that might affect my ability to complete the walk. I understand that if I have any question in my mind as to my physical or emotional ability to complete the walk I will consult with my physician to receive medical clearance. I understand and agree that I have an affirmative obligation to inform Coastwalk of any such condition, should one develop prior to the walk, by calling the Coastwalk office at: (800) 550-6854.
