Equipment Rental and Safety

Equipment inspection and responsibility for damage and theft: Prior to departure: The renting party agrees to fully inspect prior to use. The renting party will notify Russian River Outfitters of any damage to the rented Kayak, Bicycle or equipment prior to departure. Use of the equipment will constitute acceptance of the equipment, as is. The renting party agrees to reimburse Russian River Outfitters for any damages, loss or theft of Bicycles, Kayaks and/or equipment assigned to the renter during the rental agreement period.

Assignment of risk:

It is specifically understood that all use of Kayaks, Bicycles or equipment, provided by Russian River Outfitters is at the sole personal risk of the renter signed below. The undersigned agrees to assume all responsibility for the personal injury to self, kayak occupants, bike riders as a result of or in anyway connected with the use of Kayaks and Equipment or Bicycles provided by Russian River Outfitters.

Acknowledgement and acceptance of hazards:

The undersigned renter is aware that Kayaking on any creek, river, lake, estuary or coastal water, or Cycling on country roads and parks can be extremely hazardous. The undersigned certifies that they are physically able to perform swimming, paddling, and self rescue skills as may be required for Kayaking. To insure their personal safety, the renting party and all Kayak occupants agree to wear their Personal Flotation Devices (Life Jackets) at all times when they are on or near the water and Helmets when they are riding Bicycles. The undersigned assumes all risk for any injury loss and damages to person or property during any such use, fully recognizing that Russian River Outfitters and their agents have no control over the manner of use or condition of any Creek, river, lake, estuary, or coastal waters or the safety of the roads and highways.

Hold Harmless Agreement (Russian River Outfitters):

I agree to pay for defend and indemnify and hold harmless Russian River Outfitters, their agents, employees, or successors and assigns from all liabilities, claims and demands for loss or injuries to persons and property sustained by me, my heirs, children dependents and all other persons, resulting from or in any way connected with transporting or use of the Shuttle Van, Kayaks, Bicycles and/or equipment furnished by Russian River Outfitters or their agents. I further agree to pay all costs, expenses and attorney fees that may be incurred by Russian River Outfitters or their agent's successors and assigns enforcing any and all obligations under this agreement.
